Families like Angela Spencer, and her nine-year-old son, Amarion. They became homeless when Angela was furloughed from her full-time job and lost her home to foreclosure.

In addition to the hardship of losing his home, Amarion almost had to face the loss of his school. Claiming that Amarion was no longer a resident of the district because he was homeless, his school district repeatedly unenrolled him—in violation of federal law.

With the help of the Law Center and our teamwork with a local attorney in Texas, Angela was able to re-enroll Amarion in school. Today, Angela and her son are no longer homeless, and Amarion is thriving—and has a chance for a better future.

As documented in our new report, **No Barriers**, children who change schools two or more times each school year are 50% less likely to graduate high school. Those who do not complete high school will face at least a \$9,000 penalty every year on their economic earnings throughout their lifetime.

Your help, teamed with our legal expertise, ensures that children are protected under the federal McKinney-Vento Act, which guarantees for all homeless children, the right to:

- Stay in their same school, even if they are temporarily housed in a different district;
- Receive transportation to and from school;
- Receive free school meals;
